**Terms and Conditions:** Rockin' Party LLC agrees, for the terms of this agreement, to supply the Rockin' Gamin' Theatre and applicable event hosts on the date and time listed above. Commercially reasonable effort will be made to provide "on time" events, however, due to location, severe weather, or other acts of God, Rockin Party LLC will not be held liable for any damages arising from delays. Rockin Party LLC will make every attempt to notify the customer of any delays in a timely manner. Delays notwithstanding, Rockin Party LLC will arrive 10-15 minutes prior to event start times for set up.

Rockin Party LLC provides for parental/company control of age appropriate games and videos. The menu of games made available for use in the Rockin' Gamin' Theatre will be approved and authorized by the customer prior to the event.

Rockin Party LLC allows for "normal" wear and tear and provides routine maintenance on the Rockin' Gamin' Theatre. Customer agrees to compensate Rockin

Party LLC for any repairs caused by neglect, misuse, abuse, vandalism, or liquid damages to the vehicle, Rockin' Gamin' Theatre, gaming equipment, games, or televisions. Rockin Party LLC schedules and books multiple events. Customer agrees to compensate Rockin Party LLC for any delays caused by customer or guests that affects the next booked event timeline or Rockin Party LLC 's ability to perform according to this contract. In a case where Rockin Party LLC is delayed from a timely departure, customer agrees to compensate Rockin Party LLC at the rate of \$199 per hour, billed in hour increments.

Customer hereby releases and agrees to indemnify and hold harmless Rockin Party LLC for any and all property damage or personal injury arising from Rockin Party LLC performance hereunder unless caused by the gross negligence, intentionally malicious actions, or sole negligence of Rockin Party LLC. Further, customer certifies that up to date and viable insurance is in place and "in force" covering participants and property at the Rockin Party LLC event. Customer agrees to provide a copy of their "certificate of insurance" upon request. Rockin Party LLC certifies that appropriate insurance is "in force" at the time services rendered.
